

Pre-Provisional Government

1841 Meetings¹: February 17-18, June 1

This was the first committee chosen for the framing of a constitution and code of laws for the area of country known as Oregon. These members were chosen at a meeting of the inhabitants of the Willamette Valley held at the American Mission House, First Methodist Mission (10 miles below Salem on the Willamette River) in February and at the new building, near the Catholic church at St. Paul, on June 1.²

Oregon Legislators and Staff Guide 1843 Meetings (2nd Pre-Provisional): June 27-28, July 5

Pre-Provisional Government

The legislative committee was chosen at a public mass meeting held at Champooiek, May 2, 1843. The committee met at Willamette, May 16, 1843, and continued in session for three days. The committee adjourned and reconvened June 27 for two days. The legislative committee submitted reports at a mass meeting of the citizens of Oregon at Champooiek¹ on July 5. These reports were adopted as the Laws of Oregon².

1844

Pre-Provisional Government

The 3rd legislative committee chosen before the organization of the provisional government held a session at Oregon City, at the house of Mr. Hathaway, from June 18 to June 27, 1844. The same committee reconvened December 16 at Oregon City at the house of J. E. Long and continued in session until December 21.

Honorable Osborn Russell and Honorable P. G. Stewart, a majority of the executive committee submitted a message to the members of the legislative committee at the December session, in which they stated that there were adverse claims to the country known as Oregon, both Great Britain and the United States claiming the territory west of the Rocky Mountains and north of the California line.

Pre-Provisional Government

The 4th legislative committee chosen before the organization of the provisional government met at the house of J. E. Long in Oregon City. After the assembly was organized the residence of Mr. M. McGruder was secured in which to hold the sessions of the committee.

This was the last session of the legislative committee under the regime of the executive committee of Oregon. Honorable Osborn Russell and Honorable P. J. Stewart, who jointly governed Oregon as a majority of the executive committee at this time retired from office at the close of this session to give place to Honorable George Abernethy, the first governor of Oregon.

The members of this committee before entering upon the duties of their office each took the following oath:

"I do solemnly swear that I will support the organic laws of the provisional government of Oregon, so far as the said organic laws are consistent with my duties as a citizen of the United States, or a subject of Great Britain, and faithfully demean myself in office, so help me God."

Tualatin County was sometimes called *Tuality County* and is written that way in many early records. Champoeg County is also written as *Champoie* and the County of Clackamas as *Klackamas*.
