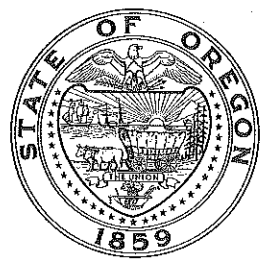
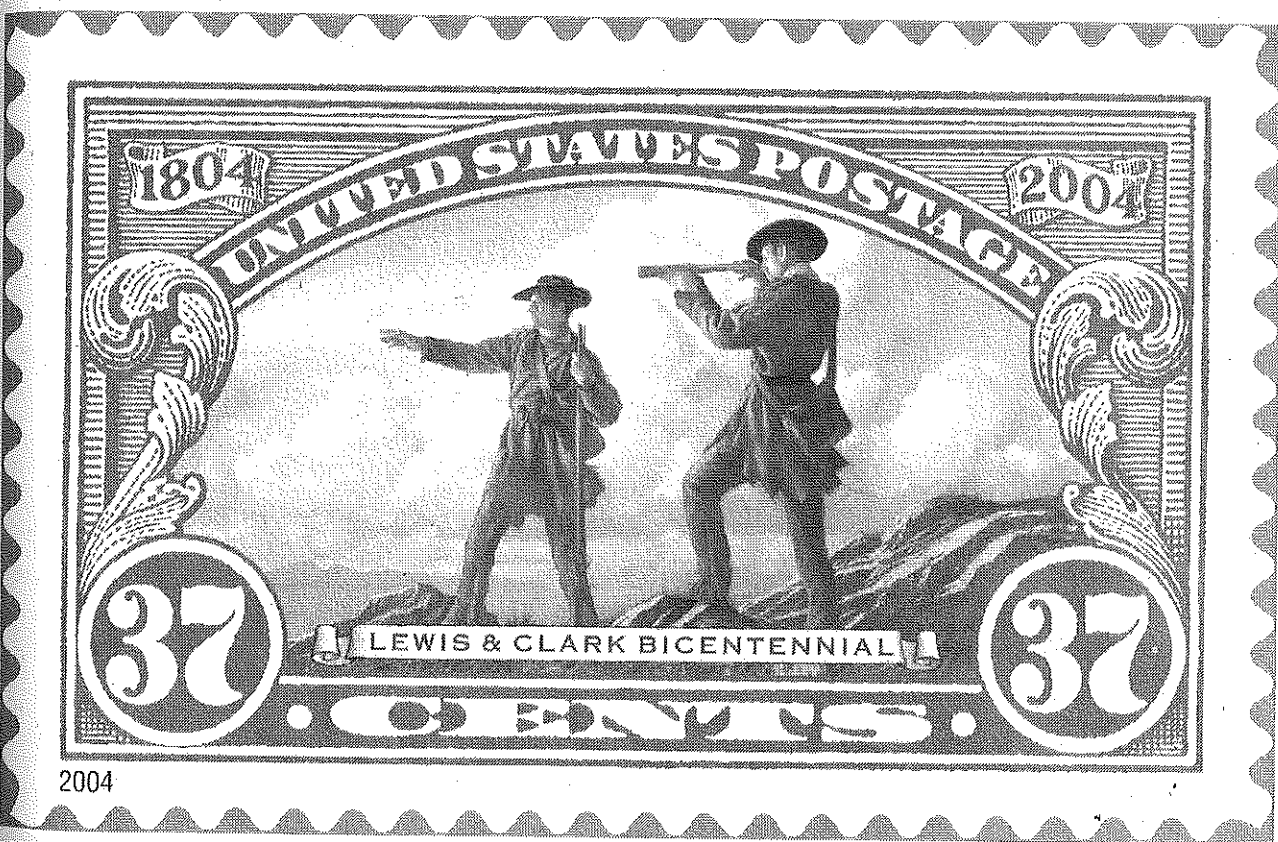

**On the cover:** Lewis and Clark Bicentennial First Class Postage commemorative stamps were issued on May 14, 2004. Special first day issue ceremonies were held in eleven locations across the nation, including both Fort Clatsop National Memorial in Oregon and Cape Disappointment in Washington. # General Information

## Voters' Pamphlet

Your official 2004 General Election Voters' Pamphlet is divided into two separate volumes. This is Volume 2 and contains information on candidates. You should have already received Volume 1, containing information on the statewide measures. If you have not received Volume 1, please call the toll-free voter information line at 1-866-ORE-VOTES (1-866-673-8683).

In this volume, partisan candidates appear before nonpartisan candidates. All space is purchased; statements and photographs are submitted by the candidates or their designated agents. The information required by law—pertaining to occupation, occupational background, educational background, and prior governmental experience—has been certified by each candidate.

Volume 2 also includes other voting aids, such as a complete listing of state candidates, drop site locations, and ballot instructions. If your county has chosen to produce a voters' pamphlet in conjunction with the state, drop site locations will appear in your county voters' pamphlet, which is in the center of this pamphlet.

**Candidate statements are printed as submitted by the author. The state does not correct punctuation, grammar, syntax errors or inaccurate information. The only changes made are attempts to correct spelling errors if the word as originally submitted is not in the dictionary.**

The voters' pamphlet has been compiled by the Secretary of State since 1903, when Oregon became one of the first states to provide for the printing and distribution of such a publication. One copy of the voters' pamphlet is mailed to every household in the state. Additional copies are available at the State Capitol, local post offices, courthouses and all county elections offices.

## Random Alphabet

While the candidates' statements for candidates running for the same office appear in alphabetical order by their last name in this voters' pamphlet, you will notice that they appear in a different order on your ballot.

Pursuant to ORS 254.155, the Secretary of State is required to complete a random order of the letters of the alphabet to determine the order in which the names of candidates appear on the ballot.

## Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by October 28. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8:00 p.m. election day, Tuesday, November 2, 2004.

### Postmarks do not count!

County elections offices are open on election day from 7:00 a.m. to 8:00 p.m.

### Measure No. 9-27

#### BALLOT TITLE

##### 09-27 TO FORM TRANSPORTATION DISTRICT AND ESTABLISH PERMANENT TAX RATE LIMIT

**Question:** Shall Bend Area Transportation District be formed and impose \$.29 per \$1,000 assessed value as permanent rate limit beginning 2005-2006?

This measure may cause property taxes to increase more than three percent.

**Summary:** A transportation district would be established covering the City of Bend, Deschutes River Woods, Juniper Ridge, the parcel south of Skyview Middle School on the West side of 18th Street south of Egypt Road, and the Pine Nursery Site. The name of the district would be the Bend Area Transportation District. The purpose of the district would be to plan, establish, furnish and maintain a system for the transportation of passengers within the Bend area and to construct, maintain and operate any related facilities pursuant to ORS 267.510 et seq.

If approved, this measure would authorize the district to tax properties within the district for the above listed services at a maximum permanent tax limit of \$.29 per \$1000 assessed value. The district taxes would be imposed starting with tax year 2005-2006 and estimated to raise \$1,697,277 in revenue in the first year. If this measure passes, the election of the governing body will be held in May 2005.

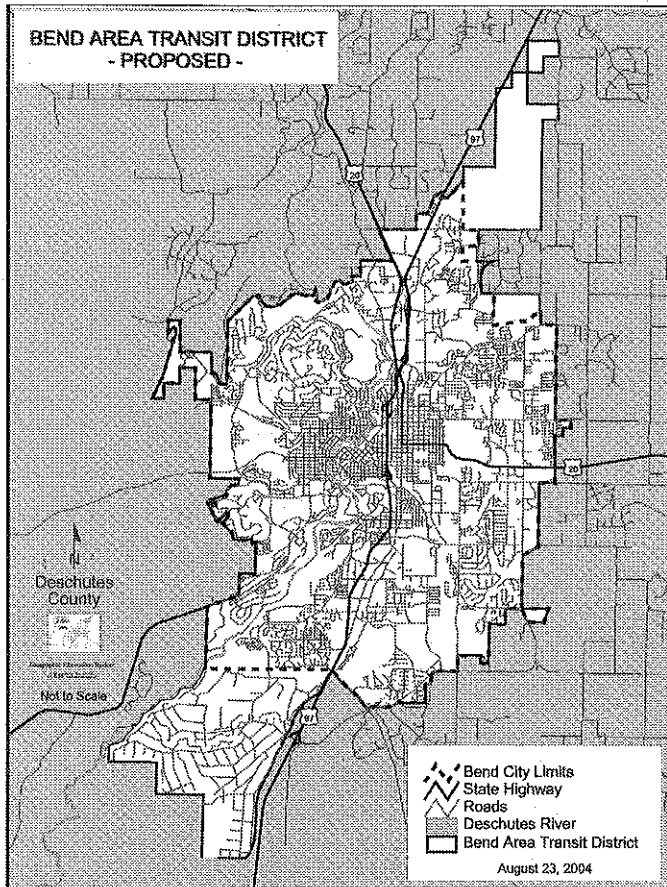
#### EXPLANATORY STATEMENT

The City of Bend ("City") filed a resolution with the Deschutes County Board of County Commissioners ("Board") requesting the initiation of the formation of the Bend Area Transportation District ("District"). The purpose of the District is to plan, establish, furnish and maintain a system for the transportation of passengers within the Bend area and to construct, maintain and operate any related facilities. As part of the efforts to provide for the transportation of passengers, the City is developing a Capital Improvements Program to be presented to the District governing body that includes a fixed-route bus system in addition to maintaining and enhancing the current Dial-A-Ride service for eligible seniors and disabled persons. Formation of the District provides eligibility to obtain federal and state matching funds for these transportation projects.

If the District is approved by the voters, an election will be held in May 2005 to elect the governing body of the District. The governing body shall consist of seven members elected from the District at large for four-year terms with the first members having staggered terms.

If approved, the maximum amount that the District could levy each fiscal year would be \$.29 per \$1,000 assessed value. The District, however, need not levy the full amount of the permanent tax rate in any given year. The District Governing Body will determine the amount to levy each year based upon the annual budget approved each year by the District Budget Committee consisting of the District governing body and seven electors from the District appointed by the District Governing Body. The District Budget Committee and District meetings will be open to the public. The estimated first year ad valorem tax levy is \$.29 per \$1,000 assessed value.

#### BALLOT TITLE

##### 09-28 FIVE-YEAR LOCAL OPTION TAX FOR DISTRICT OPERATIONS

**Question:** Shall the District levy \$0.85 per \$1000 of assessed value each year for five years beginning 2005-2006 for operations? This measure may cause property taxes to increase more than three percent.

**Summary:** This measure authorizes Administrative School District No. 1, in Deschutes County, Oregon to levy a property tax in the amount of \$.085 per \$1000 of assessed value each year for five years. The taxes would be used to help finance District operations.

An estimate of the total amount to be raised each fiscal year is:

2005-2006	\$6,267,857
2006-2007	\$6,518,571
2007-2008	\$6,779,314
2008-2009	\$7,050,487
2009-2010	\$7,332,506

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor of Deschutes County at the time of the estimate.

#### EXPLANATORY STATEMENT

##### Classroom Overcrowding and Full School Year

The Bend-La Pine School District Board has referred a 5-year local option levy that would reduce classroom overcrowding and restore a full school year. If approved, the levy would raise over \$6 million in the first year and an estimated total of \$34 million over five years.

##### Taxes Would Stay Local

All funds raised by a local option levy would stay in the community and go to local schools. Taxes would be collected by Deschutes County and distributed directly to the school district.

##### Libraries

A portion of the levy would be used to upgrade school libraries by replacing old and outdated books throughout the school district and hiring librarians.

##### Bend-La Pine Students Perform Well

Bend-La Pine students consistently outperform their Oregon peers in statewide tests and SAT scores according to the Oregon Department of Education. The District has several award winning programs and honored students and teachers. Many Bend-La Pine schools have been rated as exceptional and strong by the State of Oregon.

##### Background

The district has experienced a funding shortfall of about \$20 million over the last three school years. At the same time, student enrollment has increased almost 300 students per year. Reductions in teachers and other positions were implemented. Classrooms became more overcrowded, and student opportunities were reduced. Pay to play fees for athletics and other after-school activities were increased. In addition, already one of the shortest school years in the country, the 2004-05 school year was reduced by one week.

The downturn in Oregon's economy has led to this shortfall. Legislative attempts to solve the situation have been unsuccessful. Before 1990, local property taxes were the major source of funding for local schools. Now most funding for school budgets come from the state's general fund. Most of

Oregon's general fund comes from personal income taxes which fluctuate dramatically during an economic downturn. This leaves schools particularly vulnerable to changes in the economy. In addition, Bend-La Pine schools receive less than the state average for school districts according to the Oregon Department of Education.

##### Uses for Local Option Proceeds

If this measure passes, the school district would maintain a quality education by:

- Restoring a full school year
- Reducing classroom overcrowding
- Restoring and adding teachers
- Purchasing new educational materials, including library and text books
- Restore opportunities for students through activities and athletics

##### Estimate Your Costs

It would cost the property tax payer up to a maximum of \$.85 per \$1,000 of assessed value per year for five years. Property taxes would vary from property to property. An average home assessed at \$152,500 could cost up to approximately \$130 per year (or about \$11 per month) in additional taxes. **QUESTION:** Shall the City annex territory in the Redmond Urban Growth Boundary (UGB) as provided in the Redmond Annexation Plan?

**SUMMARY:** Approval will annex territory within the UGB generally described as follows:

SW Area bounded North by Quartz, 39th, and Wickiup, South by Elkhorn, BPA power lines and Coyote alignment, West by COID Lateral and Helmholtz Way, and East by alignment of 19th.

- ✓ Annexation will make the City of Redmond the primary government entity for the entire Redmond UGB. This centralization and consolidation of municipal services will help reduce the confusion currently experienced by citizens trying to determine which agency to call with concerns and questions.
- ✓ As a result of annexation, residents within the UGB will receive an urban level of police service. A department recognized statewide as one of Oregon's accredited premier law enforcement agencies will serve residents.
- ✓ Annexation will provide additional state revenues to the City of Redmond which is currently distributed to other parts of the state. These revenues will come from cigarette, liquor, and gasoline taxes, and other state shared revenue. Deschutes County's revenues will not be decreased because the formula used for allocating these revenues will not be affected by annexation.
- ✓ The City's Comprehensive Plan encourages annexations that eliminate existing unincorporated "islands." It discourages expansions that result in irregular boundaries, making it difficult for the police to determine a parcel's jurisdiction in an emergency situation.

### EXPLANATORY STATEMENT

The City of Redmond was incorporated on July 6, 1910. For 20 years land surrounding the town site was annexed to the City and platted into streets and lots. From the late 1920's until the mid 1960's little annexation or development occurred outside of the previously platted areas. In the late 60's and 70's, much of Deschutes County experienced rapid growth and extensive platting of subdivisions occurred throughout the county. In 1981, Redmond annexed 320 acres into the City, this being the last major annexation which occurred in Redmond.

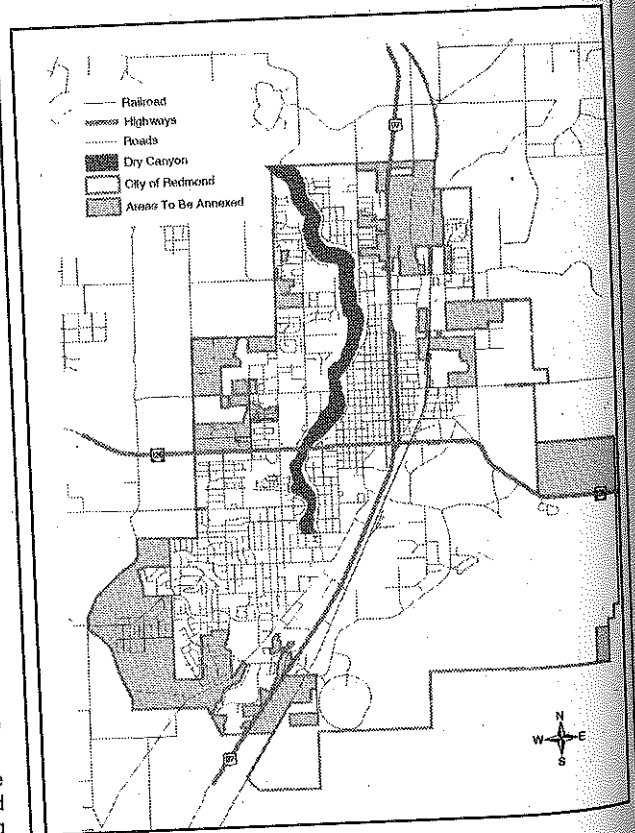
The City Council is proposing to annex the territory within the Redmond Urban Growth Boundary (UGB) that is not currently within the City. Pockets of urban development are scattered throughout this area where as of July 1, 2003, an estimated 1,100 people were living. This annexation would add approximately 2,950 acres to the City's current 7,023 acres, giving the same boundaries to the City limits and the current UGB (approximately 9,974 acres).

The City has a sewage treatment system that can currently serve approximately 24,400 people, with major sewer transmission lines having been extended throughout much of the UGB. The City has assumed maintenance and operation of County roads within the UGB under a Management Agreement with Deschutes County. The City and two private providers supply water service to the UGB. As part of another agreement between Deschutes County and the City, the City assumed responsibility for the urban growth management for the entire UGB in August 2002.

All of these changes and plans have set the framework for the development of the Redmond Annexation Plan. The proposed annexation is being put to a vote of all registered voters residing within the City and the unincorporated UGB.

#### Summary of Redmond Annexation Plan

As part of that process, the City Council commissioned a series of studies and reports on the need to incorporate that territory within the City boundaries, the cost of such an annexation to both the City residents and the residents of the territory to be annexed, the effect of the annexation on current and future urban services, and the long term benefits of such an annexation.

- The proposed annexation will provide more effective government and create economies of scale for all citizens thereby reducing the individual costs of service.
- It will enable the entire community to participate on the City Council and its committees.

#### ARGUMENT IN OPPOSITION

The City of Redmond has proposed a major annexation that will approximately double the size of Redmond. At the same time the city projects a growth of approximately 28,000 in population over the next 21 years but ignores a very important problem. Laws related to paying for growth are grossly unfair. The consequence will be continually increasing taxes for all current homeowners in Redmond.

The city collects system development charges (SDCs) for each new home in partial payment for increased needs they create - expanded road and traffic systems, sewer systems, equipment, buildings, etc. The difference between SDCs and actual costs is significant and amounts to a large subsidy paid for by property taxes.

Eben Fodor, a leading authority on growth in Oregon, estimated in a report for Alternatives to Growth Oregon ([www.agoregon.org/page51.htm](http://www.agoregon.org/page51.htm))(February 2002) the subsidy for each new resident in Oregon in 2000 would be \$18,000. If we assume 500 new homes built each year (for an average annual population growth of 1,333) and a subsidy of only \$10,000 per home, \$5 million will be added to Redmond's property tax bills annually. This last calculation does not include schools.

Redmond's last school bond indicated an average cost of \$26,000 per student for new schools. If 30% of the estimated 1,333 people to be added each year are students, approximating the current ratio, the school population will grow by 400 annually and create over \$10 million in new school construction needs every year. There are no SDCs for schools.

These subsidies will have to be paid through property taxes by Redmond's homeowners, including many who are already having problems making ends meet. The solution is to reject proposals for growth until laws are changed and cities can and do collect fair and realistic SDCs. Vote NO on annexation and against higher taxes.

##### **09-30 FOUR-YEAR LOCAL OPTION TAX FOR PROGRAMS, MAINTENANCE, AND PERSONNEL**

**Question:** Shall Sisters School District #6 impose \$.75 per \$1,000 of assessed value for general operations for four years beginning 2005-06? This measure may cause property taxes to increase more than three percent.

**Summary:** The District will use local option tax revenue to finance general operations including, but not limited to, funding for current programs; for the maintenance and repair of facilities; for the purchase of instructional materials and equipment; and for the retention of professional and support staff in order to continue the programs of the District.

The proposed rate will raise approximately \$829,920 in 2005-06; \$863,117 in 2006-07; \$897,641 in 2007-08; and \$933,547 in 2008-09; for a total of \$3,524,225.

#### EXPLANATORY STATEMENT

##### **Sisters Schools LOCAL OPTION BALLOT MEASURE**

**WHAT:** The Sisters School District is proposing the Local Option tax measure passed by voters four years ago be renewed for another four years. The funds generated are intended to preserve programs, maintain class size, provide instructional materials and equipment, and retain professional and support staff. In addition, the maintenance and repair of current facilities and other pressing needs of the District will be addressed.

**WHY:** The decrease in state funding levels has resulted in the reduction of staff and the shortening of the school year (5.4 fewer positions and 5 fewer school days for the coming school year). The revenue from the Local Option tax has enabled the District to maintain smaller class sizes; provide and update textbooks, technological equipment, library books, and other instructional materials; and preserve programs. Continued growth at all grade levels is seriously straining district resources. The Local Option revenue is essential for the District to be able to maintain the gains it has made in the past four years, as well as meet the challenges caused by growth in our district and reduced funding by the state.

**WHEN:** The Local Option measure will be on the November 2, 2004, general election ballot. Ballots will be mailed beginning October 15, 2004, and are due at the County Clerk's office no later than 8 p.m. on Election Day. To be eligible to vote, you must register by Tuesday, October 12, 2004. Registration materials are available at the County Clerk's office, the Post Office, at all Sisters schools, and online at [www.co.deschutes.or.us](http://www.co.deschutes.or.us).

**HOW MUCH:** It is estimated that the Local Option measure will raise in excess of \$800,000 each year in a four-year period for the operation of schools. The rate will be \$.75 per thousand (the same rate as the existing Local Option) of property value. Taxes for each property owner will depend on the difference between the real market value and the assessed value of each property.

**You must do both for your vote to be counted!**

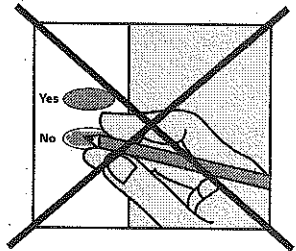
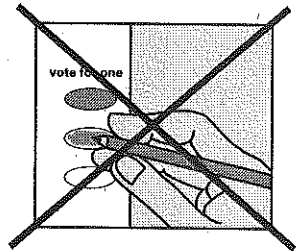


## check your ballot!

If you vote for more candidates than allowed, or if you vote **both** Yes **and** No on a measure, it is called an overvote.

Your vote **will not count** for that candidate or measure.

You do not have to vote on all contests. Those you do vote on will still count.

# General Information

## Vote-by-Mail

### What is Vote-by-Mail?

Vote-by-mail is a method of conducting elections. Instead of using traditional polling places where voters go to cast ballots on election day, a ballot is automatically mailed to each registered voter. The ballot is then voted and returned to the county elections official to be counted.

### As a voter, what do I have to do?

Your ballot packet will automatically be mailed to you between October 15 and October 19, 2004. Inside the packet you will find the ballot, a secrecy envelope and a return envelope. Once you vote the ballot, place it in the secrecy envelope and seal it in the pre-addressed return envelope. Be sure you sign the return envelope on the appropriate line. After that just return the ballot either by mail or at a designated drop site.

### What if I am uncomfortable voting my ballot at home?

Privacy booths are available for you to cast your ballot. There are privacy booths at your county elections office and there may be others at drop site locations elsewhere in your county. For further information, call your county elections official.

### What if my ballot doesn't come?

If you are registered to vote and have not received your ballot within a week after they are mailed, call your county elections office. They will check that your voter registration is current. If it is, they will mail you a replacement ballot.

### What if I have moved and have not updated my registration?

If you were registered to vote by October 12 but now have a different address, call your county elections office for instructions on how to update your registration and receive a ballot.

### Do I have to return my ballot by mail?

You have the choice of mailing your ballot or returning it to any county elections office or any designated drop site in the state. The times and locations of drop sites are available at your county elections office.

### How much postage is required to mail the ballot back?

Your voted ballot can usually be returned using a single 37¢ stamp. In those instances where additional postage is necessary, it will be clearly indicated on the ballot materials.

### When must the voted ballot be returned?

The voted ballot must be received in any county elections office or designated drop site by 8:00 p.m. on election night.

**Postmarks do not count!**

### How do I know if my ballot is received?

You can call your county elections office and ask if they received your ballot. A record is kept showing each voter whose ballot has been returned.

### Can anyone find out how I've voted once I mail my ballot?

No. All ballots are separated from the return envelope before the ballots are inspected. This process ensures confidentiality.

### What if I forget to sign the return envelope?

Generally, your elections office will either return it to you for signing or they will contact you, if possible, to come to the elections office to sign it. If the return envelope does not get signed before 8:00 p.m. on November 2, the ballot will not be counted.

### Can the public watch the election process?

All steps of the process are open to observation by the public. Contact your county elections official to make arrangements.

### When will election results be known?

Ballot counting cannot begin until election day. Initial results are released at 8:00 p.m. election night and will continue to be updated through election night until all ballots have been counted.

## Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by October 28. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8:00 p.m. election day, Tuesday, November 2, 2004.

### Postmarks do not count!

County elections offices are open on election day from 7:00 a.m. to 8:00 p.m.
