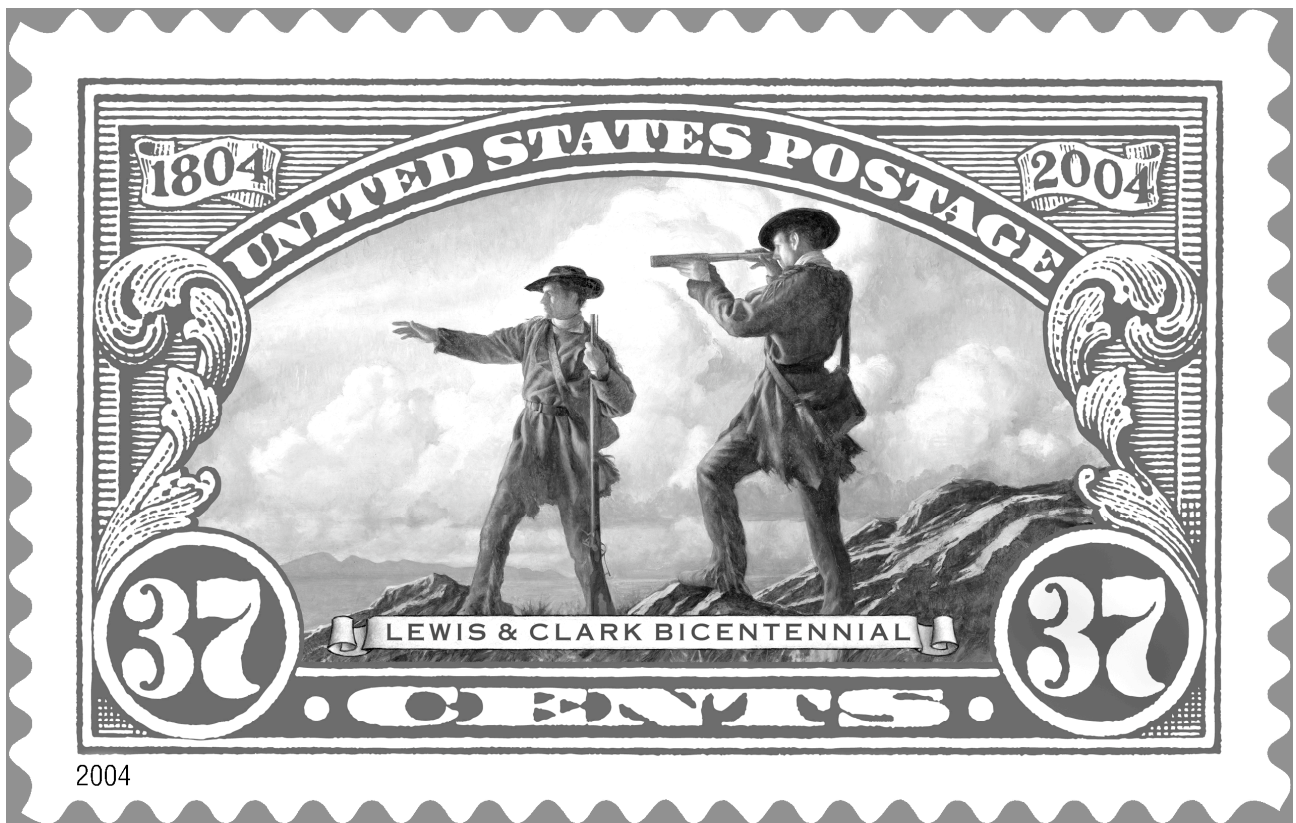

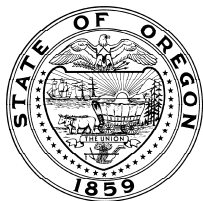

General Information

Voters' Pamphlet

Your official 2004 General Election Voters' Pamphlet is divided into two separate volumes. This is Volume 2 and contains information on candidates. You should have already received Volume 1, containing information on the statewide measures. If you have not received Volume 1, please call the toll-free voter information line at 1-866-ORE-VOTES (1-866-673-8683).

In this volume, partisan candidates appear before nonpartisan candidates. All space is purchased; statements and photographs are submitted by the candidates or their designated agents. The information required by law—pertaining to occupation, occupational background, educational background, and prior governmental experience—has been certified by each candidate.

Volume 2 also includes other voting aids, such as a complete listing of state candidates, drop site locations, and ballot instructions. If your county has chosen to produce a voters' pamphlet in conjunction with the state, drop site locations will appear in your county voters' pamphlet, which is in the center of this pamphlet.

Candidate statements are printed as submitted by the author. The state does not correct punctuation, grammar, syntax errors or inaccurate information. The only changes made are attempts to correct spelling errors if the word as originally submitted is not in the dictionary.

The voters' pamphlet has been compiled by the Secretary of State since 1903, when Oregon became one of the first states to provide for the printing and distribution of such a publication. One copy of the voters' pamphlet is mailed to every household in the state. Additional copies are available at the State Capitol, local post offices, courthouses and all county elections offices.

Random Alphabet

While the candidates' statements for candidates running for the same office appear in alphabetical order by their last name in this voters' pamphlet, you will notice that they appear in a different order on your ballot.

Pursuant to ORS 254.155, the Secretary of State is required to complete a random order of the letters of the alphabet to determine the order in which the names of candidates appear on the ballot.

The alphabet for the 2004 General Election is:

Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by October 28. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8:00 p.m. election day, Tuesday, November 2, 2004.

Postmarks do not count!

County elections offices are open on election day from 7:00 a.m. to 8:00 p.m.

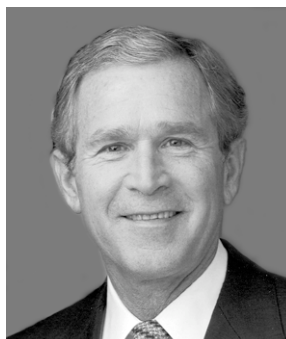

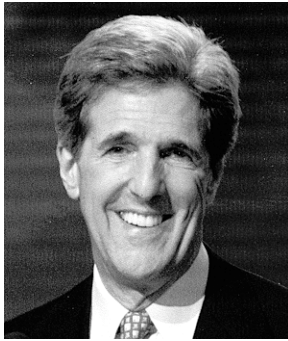

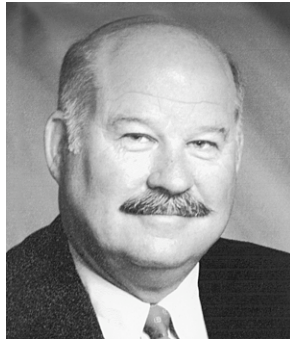
Stop environmental destruction: I oppose commercial logging on public lands. We need a roadless policy in our national forests, and should support the Kyoto Protocol to prevent global warming.

Vote-by-mail is a method of conducting elections. Instead of using traditional polling places where voters go to cast ballots on election day, a ballot is automatically mailed to each registered voter. The ballot is then voted and returned to the county elections official to be counted.

As a voter, what do I have to do?

Your ballot packet will automatically be mailed to you between October 15 and October 19, 2004. Inside the packet you will find the ballot, a secrecy envelope and a return envelope. Once you vote the ballot, place it in the secrecy envelope and seal it in the pre-addressed return envelope. Be sure you sign the return envelope on the appropriate line. After that just return the ballot either by mail or at a designated drop site.

What if I am uncomfortable voting my ballot at home?

Privacy booths are available for you to cast your ballot. There are privacy booths at your county elections office and there may be others at drop site locations elsewhere in your county. For further information, call your county elections official.

What if my ballot doesn't come?

If you are registered to vote and have not received your ballot within a week after they are mailed, call your county elections office. They will check that your voter registration is current. If it is, they will mail you a replacement ballot.

What if I have moved and have not updated my registration?

If you were registered to vote by October 12 but now have a different address, call your county elections office for instructions on how to update your registration and receive a ballot.

Do I have to return my ballot by mail?

You have the choice of mailing your ballot or returning it to any county elections office or any designated drop site in the state. The times and locations of drop sites are available at your county elections office.

How much postage is required to mail the ballot back?

Your voted ballot can usually be returned using a single 37¢ stamp. In those instances where additional postage is necessary, it will be clearly indicated on the ballot materials.

When must the voted ballot be returned?

The voted ballot must be received in any county elections office or designated drop site by 8:00 p.m. on election night.

Postmarks do not count!

How do I know if my ballot is received?

You can call your county elections office and ask if they received your ballot. A record is kept showing each voter whose ballot has been returned.

Can anyone find out how I've voted once I mail my ballot?

No. All ballots are separated from the return envelope before the ballots are inspected. This process ensures confidentiality.

What if I forget to sign the return envelope?

Generally, your elections office will either return it to you for signing or they will contact you, if possible, to come to the elections office to sign it. If the return envelope does not get signed before 8:00 p.m. on November 2, the ballot will not be counted.

Can the public watch the election process?

All steps of the process are open to observation by the public. Contact your county elections official to make arrangements.

When will election results be known?

Ballot counting cannot begin until election day. Initial results are released at 8:00 p.m. election night and will continue to be updated through election night until all ballots have been counted.

Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by October 28. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8:00 p.m. election day, Tuesday, November 2, 2004.

Postmarks do not count!

County elections offices are open on election day from 7:00 a.m. to 8:00 p.m.

A STRONG FOUNDATION. We represent a worldwide movement founded 175 years ago to radically expand democracy into all aspects of human life: economic, political and social. The term “socialist” was first used in the *Cooperative Magazine* (Nov. 1827) to describe the efforts of Robert Owen, a Welsh mill owner, “to develop co-operative societies of people who would produce goods for their common good.” The Socialist Party was founded in 1901 by a diverse group of concerned citizens, including African Americans.

WHO’S WHO. Some great Americans have been socialists: Eugene Victor Debs (American Railway Union founder), Mary “Mother” Jones (Steelworkers organizer), Helen Keller (deaf & blind lecturer), Susan B. Anthony (women’s-suffrage leader), Margaret Sanger (birth-control leader), Emma Lazarus (poet, “Give me your tired, your poor, your huddled masses yearning to be free”), Jack London (author, *Call of the Wild*), Upton Sinclair (author, *The Jungle*), Michael Harrington (author, *The Other America*), Congressman Meyer London (chief sponsor of first workers’ compensation law passed by Congress), Morris Hillquit (labor lawyer), Carl Sandburg (*Lincoln* author), Albert Einstein (physicist), Frank Zeidler (Mayor of Milwaukee, Wis.), Norman Thomas (Harlem minister, “The Conscience of America”).

A. Phillip Randolph, “Father of the Civil Rights Movement”, founded the Railway Pullman Porters Union, chaired the Socialist Party, served as the first African-American Vice-President of the AFL-CIO, and received the Presidential Medal of Freedom from Johnson in 1964.

SIGNIFICANT SUPPORT. Since 1901 millions of Americans have voted Socialist. Thousands of Socialists have held public office, several in the U.S. House of Representatives. In an earlier day, in Oregon’s “rural areas, a popular Socialist could count on a vote of 15 to 25% without much campaigning.” (*Northwest Magazine*, 12/6/76). In 1998 the Socialist candidate in Oregon’s House District 7 received over 25% of the vote.

SOCIALIST “ROOTS”. Consumer co-operatives like Recreation Equipment, Inc., credit unions, people’s utility districts, rural electric co-ops, city lighting departments like Eugene’s EWEB all have socialist “roots”. Their primary goal is to serve their owner-customers. Under capitalism, the “bottom line” is profits, not people.

NO TOTALITARIAN TIES. We don’t support communism, fascism, or any other form of despotism. We oppose the Federal Government’s using our tax dollars to arm, aid, or comfort any dictatorship anywhere. It has been the Democratic and Republican administrations in Washington, D.C. -- more concerned for corporate profits than human rights -- which have championed giving “Most Favored Nation [Trade] Status” to Communist China, the dictatorship which has raped and pillaged Tibet and imprisoned religious and political dissidents, even those seeking to organize free labor unions.

IMPORTANT CONTRIBUTIONS. For nearly 100 years Socialists have advocated much of what’s best in America. “It was the Socialist Party that first advocated creation of a Social Security system. It was the Socialists who demanded that the federal government guarantee workers the right to bargain collectively, set a minimum wage and a limit on working hours.” (Meister, *The Oregonian*, 9/4/91)

VOTE SOCIALIST. This year there will be Socialist candidates on the ballot in a number of Oregon counties. Don’t waste your vote on a Republicrat candidate who will really not represent you.
