LC 14 - Honoring Lieutenant Fred Pokorney - At the request of Rep. Andy Olson

LC 16 - Honoring Deputy Thomas Robert Farrell - At the request of Rep. Ron Noble

LC 43 - Congratulating Oregon State University on its 150th Anniversary - At the request of OSU

LC 58 - Honoring Trooper Ralph Bates - At the request of Rep. Andy Olson

LC 173 - Modifies the requirement that a city over 2,500 population or a county over 15,000 population allow development of accessory dwelling unit in area zoned for detached single-family dwelling. Makes the requirement applicable only if area is within urban growth boundary. Declares an emergency, is effective July 1, 2018. - At the request of Speaker Tina Kotek

LC 186 - Timelines resolution for 2018 Legislative Session

LC 187 - Honoring Marine Lance Cpl. Bryan Bertrand - At the request of Sen. Arnie Roblan and Rep. Caddy McKeown

LC 249 - Requires the Secretary of State to study and analyze the implementation of laws relating to elections that were passed during 2017 regular session of Legislative Assembly. Requires the Secretary of State submit a report to the interim committees on rules no later than October 1, 2019. - At the request of Rep. Williamson

LC 250 - Requires the Secretary of State to identify each law enacted and administrative rule adopted in 2017 that has an effect on signature collection for ballot measures. Requires the Secretary of State submit a report to interim committees on rules detailing content of each identified law and administrative rule by October 1, 2019. - At the request of Rep. Williamson

LC 254 - Honoring Ryan Grimaldi - At the request of Rep. Sheri Malstrom
