NOTES

The column showing date of construction refers to the year in which the now existing plant was completed. A few plants were modernized during the year indicated, utilizing some of the structures of old plants. Some cities had septic tanks which were abandoned in the year shown as the date of the existing plant.

State institutions located outside of cities are generally served by septic tanks. Other public and private institutions also have such facilities. Multnomah County Farm (population about 800) is served by a modern trickling filter type plant, built in 1935.
