Personal Property Description

To UCC-1 Financing Statement

A. All personal property of JV Foods LLC, whether such property or JV Foods LLC's right, title or interest therein or thereto is now owned or existing or hereafter acquired or arising, which personal property is now or hereafter attached to, or used or adapted for use in the operation of, the real property located in Lane County, Oregon, and more particularly described on Exhibit A attached hereto, including JV Foods LLC's marijuana foods business licensed by the State of Oregon pursuant to Chapter 845, Division 25 of the Oregon Administrative Rules ("Oregon Marijuana Rules"), all inventory (including all "Marijuana" and "Marijuana items" as defined in the Oregon Marijuana Rules), equipment, other goods, accounts (including accounts receivable), general intangibles (including the "License Rights", as hereinafter defined), chattel paper (whether tangible or electronic), instruments (including promissory notes), investment property (including securities, securities accounts, commodity contracts and commodity accounts), documents, deposit accounts, letter-of-credit rights, supporting obligations, cash and other money, and all proceeds of each of the foregoing (collectively, the "Collateral").

It is JV Foods LLC's intention that pursuant to the above grant, Rainbow Wallis Street LLC is a secured party (as defined in the UCC) and shall have all of the rights of a secured party available under 845-025-1260 and 845-025-1275 of the Oregon Marijuana Rules and JV Foods LLC hereby grants to Rainbow Wallis Street LLC all such rights.

The Collateral in which JV Foods LLC grants Rainbow Wallis Street LLC a security interest includes all of JV Foods LLC's right, title and interest, now or hereafter, in and to the following (collectively, the "License Rights"):

- (a) all licenses, permits and similar rights relating to the right to operate as a Marijuana foods business (as that term is defined in the Oregon Marijuana Rules) from JV Foods LLC including all licenses, permits and similar rights identified as follows (collectively, the "Licenses Proper"):
 - (i) Marijuana processor license number 1014658322F issued by the Oregon Liquor Control Commission ("OLCC") for JV Foods LLC in Eugene, Oregon; and
- (b) all cash and non-cash proceeds of any nature whatsoever generated from the sale, exchange, disposition or other transfer of the Licenses Proper or any part thereof (collectively, the "License Proceeds"), including any such sale, exchange, disposition or other transfer of the Licenses Proper or any part thereof to any person or entity pursuant to any sale, exchange, disposition or other transfer approved at any time by OLCC.
- B. All present and future contracts and policies of insurance which insure the Property or any building, structures, or improvements thereon, or any such fixtures or personal property, against casualties and theft, and all proceeds and rights thereto which may be or become payable by virtue of any such insurance contracts or policies.
- C. All the rents, revenues, issues, profits and income of the Property, and all right, title, and interest of Debtor in and to all present and future leases and other agreements for the occupancy or use of all or any part of the Property, and all right, title and, interest of

- Debtor thereunder, including, without limitation, all cash or security deposits, advance rentals, and deposits or payments of similar nature, together with all guaranties of tenants' or occupants' performance thereunder.
- D. All general intangibles relating to the development or use of the Property, including, without limitation, all permits, licenses, and franchises, all names under or by which the Property may at any time be operated or known, and all rights to carry on business under any such names or any variant thereof, and all trademarks, trade names, logos, and good will in any way relating to the Property.
- E. All water stock relating to the Property, all shares of stock or other evidence of ownership of any part of the Property that is owned by Debtor in common with others, and all documents or membership in any owners' or members' association or similar group having responsibility for managing or operating any part of the Property.
