THE SERVICE MARK IS A CIRCULAR DESIGN WITH VARYING COLORS OF WHITE, BLUE AND BLACK. THE CIRCLE HAS A NARROW EXTERIOR BAND ALONG THE EDGE AND AN INTERIOR BLACK BAND RUNNING ALONGSIDE THE BLUE BAND, WITH THE CENTER AREA FILLED WITH BLUE THAT GRADUALLY FADES TO WHITE AT THE CENTER, OREGON PARALEGAL ASSOCIATION IS PRINTED OUTSIDE THE CIRCLE AND IS INTENDED TO IDENTIFY THE APPLICANT OWNER NAME OF THE SERVICE MARK. THE OCP INITIALS CENTERED IN THE MIDDLE OF THE CIRCLE REPRESENT AN ACRONYM FOR THE OREGON CERTIFIED PARALEGAL ASSOCIATION.
