Can you include that information on the SEL 797? I think a note that says the tally system read one vote as an undervote but the counting board determined voter intent would be helpful. By updating the SEL 797 to include that information we'll be able to clearly demonstrate how the automatic recount satisfied the purpose of the hand count, confirmed that the tally system counted the ballots correctly and that there was no need to count additional ballots because of this change.

I'm thinking about someone reviewing the form in the future and how to best document and retain the nuances of this particular automatic recount/hand count.

However, I do have some questions about the SEL 797 you sent. On that form you marked that the results had changed which raises some concerns because the automatic recount you conducted should be able to identify any issues with the tabulators. And a hallmark of tabulation issues is results changing after recount.

So, in light of the changed results can you please provide an explanation as to what led to that result? Was that change directly related to the tally system or other election processes?
