→ Valid votes that have been marked by the voter outside the vote targets or using a marking device that cannot be read by the vote tally system shall not be included in making the determination whether the voting system has met the standard of acceptable performance for any precinct or ballot batch under ORS 254.529(7)(a) through (c) and are to be listed as exceptions.

Presidential contest:

2 batches had a write-in oval filled with a comment. They were both determined to be undervotes.
 1 batch had a write-in without the oval filled. It was determined to be a valid write-in.

Attorney General contest:

2 batches had a write-in oval filled with a comment. They were both determined to be undervotes.
