Legal Status of Sports Betting

Always Legal in Oregon

- Lottery Commission has authority to authorize any game via "any existing or future methods"
- Lottery authorized Sports Action (ended in 2007)
- Oregon was exempt from federal law prohibiting sports gambling

Professional and Amateur Sports Protection Act of 1992 (PASPA)

• Federal legislation that effectively outlawed sports betting nationwide, excluding a few states (including Oregon)

Murphy v. National Collegiate Athletic Association (May 2018)

- U.S. Supreme Court ruled that states should have the right to regulate and tax sports betting, and that it was unconstitutional for the federal government to ban them from doing so.
- Opened the door to all states to offer different approaches to sports betting.



Current Status of Sports Betting in Other States

- Thirteen states (including Oregon) have legal sports betting (Arkansas, Nevada, Delaware, New Jersey, Mississippi, West Virginia, New Mexico, Pennsylvania, Rhode Island, New York, Iowa, and Indiana)*
- Many other states have recent or pending legislation (e.g. Montana, Washington D.C., etc.)*
- Early results show revenue is exceeding expectations, especially where mobile is available (NJ, PA, NV, WV).

Why Sports Betting in Oregon?

Responsible Revenue Growth Strategy

- Increases revenue to the state without asking current players to play more by attracting new players
- Lottery has not launched a new game in more than a decade
- Player Demand:
 - An estimated 28 million Americans would wager on sports if it was legal (American Gaming Association (AGA));
 - About 375,000 Oregonians bet on sports in the past six months;
 - Nearly one in five Americans bet on sports in the past year;
 - Americans bet more than \$15 billion on the Super Bowl and March; and Madness; 97 percent of that was illegal (AGA).

**Potential data royalty fees, payment processing fees, third-party vendor costs for services such as Know Your Customer (KYC), geolocation and other data feeds, marketing and promotional spend, staffing costs, hardware costs, retail commissions, and reserve funding.

***Factors impacting revenue: illegal sports market is not expected to entirely transfer (incentives like tax avoidance, etc.); sports betting is high volume, but low margin; sports betting will never replace revenue from VLTs and other traditional Lottery products.

Overview of Scoreboard

- Available through the Scoreboard mobile app or website
- Full range of domestic and international sports
- Full range of wagering options including single-event wagering, parlay and in-play/live wagering
- Legal, Secure, Age 21+
- Geo-fenced can play anywhere in Oregon except on tribal lands
- Full suite of Responsible Gaming tools
- Prizes subject to same tax reporting and withholding and child support/DHS/OHA debt checks as other Lottery game prizes





Betting Types in Scoreboard

Single Event

- Betting on the outcome of a single sporting event.
- Event can be upcoming or in the distant future (Super Bowl winner).

Parlay

- Combines two or more wagers for higher potential return.
- All sections in the parlay must succeed for the bet to win.
- Can include wagers across multiple leagues or markets.

In-Game

- Wagers placed after the event start time.
- Lines and odds are updated throughout the event.
- Allows wagers on the outcome of the event or the likelihood of something happening within the event.



Responsible Gaming Integration

- **Deposit Limit Required:** To register for a player account, and in advance of wagering, every customer must set a deposit limit amount.
- Knowledge is Power: Play history is no longer anonymous; players can see how much they spend on gaming over time.
- Odds, payouts and how games work: This information is fully integrated into game content.
- Loss limits: In addition to the required deposit limit, players can set additional personal limits in their player account, such as a loss limit.
- Time-outs and Self-exclusion: Up to 30 day "time out" from ability to access Scoreboard and receive marketing or temporary or even permanent self-exclusion from having a player account.
- **<u>NOTE</u>**: Director Pack is committed to no high-velocity games (VLTs) on mobile.



Responsible Gaming Integration

Lottery will implement RG training for call center staff

- Working with RG training experts, Lottery will develop custom training for vendor call center staff
 - In-person training
 - Online resources
 - Chat scripts
 - Escalation processes
- Lottery will work with OHA to train and familiarize helpline staff
- Lottery "hotline" staff will receive updated RG training
