#### Public Hearing

SB 299

Authorizes formation of children's service districts.

SB 119

Requires taxpayer-creator to obtain appraisal report to substantiate fair market value of art object for purpose of subtraction allowed for donation of art object.

SB 120

Aligns direction to Department of Revenue to pay interest on certain tax refunds with other tax refund provisions and with current systems and processes.
