CARIED OVER FROM 3/23/21/ MEETING Exempts from ad valorem property taxation machinery and equipment used to compress and bale harvested straw, hay, grass or other plants.

HB 2096 A

Increases maximum agriculture workforce housing tax credits issued by Housing and Community Services Department to \$24 million per biennium.

HB 2446

Extends sunset of property tax exemption for property of nonprofit corporation offered, occupied or used as low-income housing.

HB 2584 A

Increases total amount of tax credits for affordable housing lenders allowed for all taxpayers per fiscal year.
