NEED FOR THE RULE(S):

This amended rule is needed to close the Tillamook Bay commercial dive gaper clam fishery due to the attainment of the annual harvest quota.

JUSTIFICATION OF TEMPORARY FILING:

There is not adequate time to go through normal rulemaking proceedings prior to the close of this commercial clam fishery.

Failure to adopt these rules would cause serious prejudice to the public interest by allowing commercial clammers to overharvest gaper clams in Tillamook Bay, which could result in greater harvest restrictions for future fisheries.

RULE TITLE: Catch Limits

RULE SUMMARY: This amended rule closes the Tillamook Bay commercial dive gaper clam fishery on August 8 as the fishery is projected to reach the 235,000-pound quota.

RULE TEXT:

(1) In Tillamook Bay, the annual commercial landing caps for clams harvested by the bay clam dive fishery are as follows:

(a) 185,000 pounds for cockles;

- (b) 235,000 pounds for gaper clams; and
- (c) 225,000 pounds for butter clams.
- (2) In Yaquina Bay, the commercial annual landing cap for gaper clams harvested by the bay clam dive fishery is 20,000 pounds.
- (3) When any of the annual commercial clam landing caps specified in section (1) or (2) of this rule are reached, the commercial clam fishery for that species in that particular estuary will close for the remainder of the calendar year.
- (4) Effective June 22, the cockle fishery described in section (1)(a) is closed due to the attainment of the landing limit.
- (5) Effective August 1, the butter clam fishery described in section (1)(c) is closed due to the attainment of the landing limit.
- (6) Effective August 8, the gaper clam fishery described in section (1)(b) is closed due to the attainment of the landing limit.
