
- Article 1: Name of the corporation: SCHOOL SAFE ZONE SOLUTION

- Article 4: This corporation is a public benefit corporation. It will not have members.
- Article 5: In the event of dissolution of the corporation, its assets will be distributed to a nonprofit corporation engaged in benefitting the school children of Jackson County, Oregon.
- Article 6: The Directors shall be considered immune from liability to the corporation or the members for monetary damages for conduct as Directors to the fullest extent allowed by Oregon law.

- Article 8: This organization is organized and operated exclusively for charitable purpose within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
