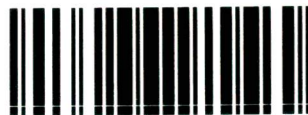

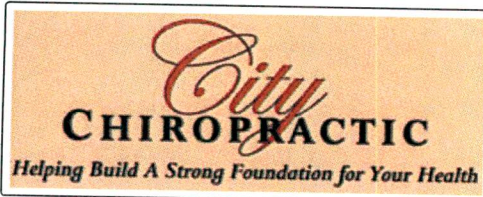

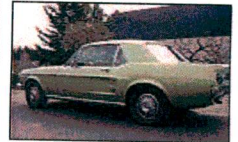
Our Mission: to provide housing, education and a supportive community so homeless families can regain their independence and transform their lives.
