ASSIGNMENT OF TRADENAMES

This Assignment of Tradenames (this "Assignment") is entered into on May 10, 2022 (the "Effective Date") by and among Cookies Creative Consulting & Promotions, Inc., a California corporation ("Cookies"), RNLC Sub LLC, a California limited liability company ("RNLC" and, along with Cookies, "Assignor"), and 3615 Market, LLC, a California limited liability company ("Assignee"). Cookies, RNLC and Assignee are sometimes referred to herein collectively as the "Parties" and each individually as a "Party."

RECITALS

WHEREAS, Cookies and Assignee are party to that certain limited liability company Operating Agreement, dated May 3, 2019 (the "Operating Agreement") of RNLC;

WHEREAS, in connection with entering into the Operating Agreement, RNLC and Assignee entered into that certain (a) Contribution Agreement, dated May 3, 2019 (the "Contribution Agreement"), under which Assignee contributed the tradename "Runtz" and variations thereof related to 3615 Market, LLC's products and business operations ("Tradenames") and Contributed Assets, as defined in the Contribution Agreement (collectively, the "Runtz Marks") to RNLC, and (b) Assignment of Tradenames, dated May 3, 2019 (the "Assignment Agreement"), under which Assignee assigned the Tradenames to RNLC;

WHEREAS, as of the Effective Date, the Parties have mutually determined to rescind the Operating Agreement, Contribution Agreement and Assignment Agreement (the "Mutual Termination") pursuant to the terms and conditions of that certain Termination, Settlement and Release Agreement to which this Assignment is attached as Exhibit B (the "Termination Agreement"); and

WHEREAS, the execution and delivery of this Assignment is a condition to the Termination Agreement and the consummation of the Mutual Termination.

NOW, THEREFORE, in consideration of the mutual covenants contained in this Assignment and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

AGREEMENT

- Assignor hereby assigns to Assignee the entire right, title and interest throughout the world in and to (a) all Runtz Marks and any respective applications, registrations or renewal thereof, together with the goodwill of the uses or business symbolized by and associated with the Runtz Marks and all rights to bring suit for past or future infringement of the Runtz Marks; and (b) all tradenames, trademarks and any respective applications, registrations or renewal thereof and related intellectual property rights related to the "Runtz" brand and/or name under all applicable state, federal and international laws together with the goodwill of the uses of the business symbolized by and associated with the tradenames and all rights to bring suit for past or future infringement; any other trademarks, copyrights, tradenames, or intellectual property rights RNLC or Cookies has acquired to the "Runtz" brand subsequent to the Contribution Agreement and any and all derivative rights; and any intent-to-use trademark applications for "Runtz", including the trademarks listed on Exhibit A.
- 2. To Assignor's knowledge, Assignor owns good, marketable title to the Tradenames and Runtz Marks free and clear of any encumbrance, title imperfection, or restriction of any kind whatsoever

(whether accrued, absolute, contingent, or otherwise).

- 3. Following the execution hereof, each of the Parties hereto shall, and shall cause their respective affiliates to, execute and deliver such additional documents, instruments, conveyances and assurances and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment. In furtherance of the foregoing, and at Assignees' sole cost and expense, Cookies shall execute any documents and provide any testimony 3615 deems reasonably necessary to maintain, protect, or enforce the Runtz Marks and that 3615 is unable to obtain from others.
- 4. This Assignment shall be governed by and construed in accordance with the internal laws of the State of California without giving effect to any choice or conflict of law provision or rule (whether of the State of California or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of California.
- 5. ANY LEGAL SUIT, ACTION OR PROCEEDING ARISING OUT OF OR BASED UPON THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY MAY BE INSTITUTED IN THE FEDERAL COURTS OF THE UNITED STATES OF AMERICA OR THE COURTS OF THE STATE OF CALIFORNIA IN EACH CASE LOCATED IN THE COUNTY OF SONOMA, AND EACH PARTY IRREVOCABLY SUBMITS TO THE EXCLUSIVE JURISDICTION OF SUCH COURTS IN ANY SUCH SUIT, ACTION OR PROCEEDING. SERVICE OF PROCESS, SUMMONS, NOTICE OR OTHER DOCUMENT BY MAIL TO SUCH PARTY'S ADDRESS SET FORTH HEREIN SHALL BE EFFECTIVE SERVICE OF PROCESS FOR ANY SUIT, ACTION OR OTHER PROCEEDING BROUGHT IN ANY SUCH COURT. THE PARTIES IRREVOCABLY AND UNCONDITIONALLY WAIVE ANY OBJECTION TO THE LAYING OF VENUE OF ANY SUIT, ACTION OR ANY PROCEEDING IN SUCH COURTS AND IRREVOCABLY WAIVE AND AGREE NOT TO PLEAD OR CLAIM IN ANY SUCH COURT THAT ANY SUCH SUIT, ACTION OR PROCEEDING BROUGHT IN ANY SUCH COURT HAS BEEN BROUGHT IN AN INCONVENIENT FORUM.
- 6. The Parties agree that irreparable damage would occur if any provision of this Assignment were not performed in accordance with the terms hereof and that the parties shall be entitled to specific performance of the terms hereof, in addition to any other remedy to which they are entitled at law or in equity.
